

Falcon Photography/Art Show II!



Last year's show was so successful that Sally Wood Winslow, director of the High Falls Gallery, has invited the dedicated followers of Mariah, Kaver and their amazing offspring to contribute to another exhibit of Rochester Peregrine Falcon photography and art this year. Works will be shown at the High Falls Gallery on Brown's Race in Rochester, a New York State Historic District, from 28 June – 31 August 2008.

The Gallery has, again, graciously arranged to display the works in our exhibit so that those outof-town falcon watchers who will be joining us during the weekend of 27-29 June will be able to view the exhibit. Many thanks to Sally for accommodating our timeframe.

We welcome art media including: photographic (digital or film), paintings, drawings, printmaking, or mixed media.

- **4** For wall display: 11 x 14" in 16 x 20" frame suggested.
- **4** No colored mats or frames please. Standard metal frames (black preferred).

NEW THIS YEAR

You don't have to have all (or any) of your work framed! Artists are encouraged to contribute photos, drawings, etc., matted without frames. We will display unframed work in flip-racks around the Gallery.

4 For browser "flip racks": 8x10" finished mat dimension and larger. Try a 5x7" photo in an 11x14" mat or a 4x6" image in an 8x10" mat – see how you like the effect. Or combine different-sized images in a large mat to make a collage. You can also put unframed prints in the flip-racks, of any work you are displaying on the walls – consider adding different sizes, priced accordingly. No frames necessary for the flip-racks.

Please protect your images from fingerprints with mylar bags or wrap. Mylar wrap is available through the Gallery at \$2/per image.

Minimum image size for works on the walls: 11" x 14" in a 16" x 20" frame suggested. Smaller image sizes are eligible when their size is inherent to the theme or presentation. You could, for example, have four 4" x 6" prints matted together in a 16" x 20" frame, showing a sequence of photos or a related theme. All work should be framed and ready for hanging.

GVAS will be pleased to provide the \$15 entry fee for each artist. Attached is an entry form for the exhibit; please read it carefully, as there are more guidelines noted there. We will consider up to six (6) entries from each artist. The entry form is a Word document, so you can print it, fill it out, and then send by 4 June <u>latest</u>:
